

Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated July 29, 2015 which reads as follows:

“G.R. No. 212027 (People of the Philippines v. Adrian Panasaga Tamboon). - After a judicious perusal of the records, the Court resolves to **DISMISS** the appeal for failure to sufficiently show that the Court of Appeals (CA) committed any reversible error in its assailed Decision as to warrant the exercise of the Court’s appellate jurisdiction. The Court, however, deems it proper to increase the award of moral damages from ₱50,000.00 to ₱75,000.00 to conform with prevailing jurisprudence.¹

WHEREFORE, the Court **ADOPTS** the findings of fact and conclusions of law in the January 29, 2014 Decision² of the CA in CA-G.R. CR HC No. 00847-MIN and **AFFIRMS** said Decision finding accused-appellant Adrian Panasaga Tamboon **GUILTY** beyond reasonable doubt of the crime of Murder in violation of Article 248 of the Revised Penal Code, with **MODIFICATION** as to the award of moral damages, sentencing him to suffer the penalty of *reclusion perpetua*, without eligibility for parole, and to indemnify the heirs of the victim the following amounts: (a) ₱75,000.00 as civil indemnity; (b) ₱75,000.00 as moral damages; (c) ₱30,000.00 as exemplary damages; and (d) ₱41,106.50 as actual damages, with legal interest at the rate of six percent (6%) per annum on all damages awarded from the date of finality of this Decision until full payment.


