

Sirs/Mesdames:

*Please take notice that the Court, First Division, issued a Resolution dated **June 29, 2015** which reads as follows:*

“G.R. No. 213218 (People of the Philippines v. Jacqueline Parohinog y Dolloso). - After a judicious perusal of the records, the Court resolves to **DISMISS** the appeal for failure to sufficiently show that the Court of Appeals (CA) committed any reversible error in upholding the conviction of accused-appellant Jacqueline Parohinog y Dolloso for violation of Sections 5 and 11, Article II of Republic Act No. (RA) 9165,¹ otherwise known as the “Comprehensive Dangerous Drugs Act of 2002.”

WHEREFORE, the Court **ADOPTS** the findings of fact and conclusions of law in the February 10, 2014 Decision² of the CA in CA-G.R. CR HC No. 01478 and **AFFIRMS** said Decision finding accused-appellant Jacqueline Parohinog y Dolloso **GUILTY** beyond reasonable doubt of Illegal Sale and Possession of Dangerous Drugs, sentencing her to suffer the following penalties: (a) life imprisonment and to pay a fine in the amount of ₱500,000.00, with costs, for violation of Section 5, Article II of RA 9165; and (b) indeterminate imprisonment for a period of twelve (12) years and one (1) day, as minimum, to fourteen (14) years and eight (8) months, as maximum, and to pay a fine in the amount of ₱300,000.00, with costs, for violation of Section 11, Article II of the same Act.




